At the Union League Boys & Girls Clubs, Child Safety is Job No. 1

Ensuring child safety is fundamental to the mission of the Union League Boys & Girls Clubs

The Safety and Wellbeing of Young People is Our Number One Priority

We work every day to create a safe, fun environment so kids can have every opportunity to be successful in life. We have ZERO tolerance for inappropriate behavior of any kind, including child sexual abuse or misconduct, and we put resources behind that stance.

Culture of Safety: The Union League Boys & Girls Clubs continually updates robust safety policies, programs and training for our staff and volunteers that are designed to promote child safety and protect young people from threats that are present in our society. We implement layers of safety policies and guidelines to keep our kids safe including:

- Hiring Policies
- Drugs and alcohol policies
- Bathroom usage policies
- Supervision policies
- Transportation policies
- Club members and adults interactions policies

Safety Policies: The Union League Boys & Girls Clubs has comprehensive safety policies in place that protect youth – including, but not limited to, hiring policies, drugs and alcohol policies, supervision, transportation, communication and prohibiting private one-on-one contact.

24-hour Toll-free Child Safety Hotline: We encourage all staff, members and families to report any incident or situation they feel is unsafe. Through our national partnership with [Praesidium](#), one of the nation's leading safety experts, the Union League Boys & Girls Clubs members and staff have access to a confidential 24-hour toll-free Child Safety Hotline, [866-607-SAFE \(7233\)](tel:866-607-SAFE) or email SafeClub@Praesidiuminc.com.

Mandatory Background Checks: Mandatory criminal background checks are required every year for every staff and board member at the Union League Boys & Girls Clubs. In addition, criminal background checks are required for any volunteer who has direct contact with children. All potential employees and volunteers are also run through Accu Biometrics which includes National Sex Offender Registry, city, county, state and all 50 state criminal background checks and FBI national fingerprint check. Our staff that work for CPS school based sites, go through the CPS internal criminal background check.

Required Immediate Reporting: The Union League Boys & Girls Clubs' staff and volunteers are all mandated reporters. We are required to report any critical incident/safety concern to local authorities immediately. We are also required to report any critical incident to Boys & Girls Clubs of America within 24 hours.

Mandatory Annual Safety Assessments: We complete a safety assessment each year to ensure we continually make improvements to safety at our Clubs.

Safety Trainings: Ongoing training and supervision of staff is critical. We participate in a wide variety of child safety training conducted such as BGCA Abuse Prevention Training and other seminars, conferences,

webinars and three safety trainings every year. We also engage leading third-party safety experts to provide guidance for our policies and approaches, including Praesidium, the National Center for Missing & Exploited Children, and the National Children's Advocacy Center.

Safety Committee: The Union League Boys & Girls Clubs has a dedicated safety committee to provide input and guidance on local policies and safety strategies. Priorities and initiatives include:

- The Safety Committee oversees all policies and procedures related to the effective implementation of safety strategies to ensure the wellbeing of all young people entrusted to the Boys & Girls Clubs.
- The Safety Committee has developed a Risk & Crisis Management Manual which is revised annually.
- The Safety Committee periodically provides organizational all staff training for all full and part time staff including volunteers at least twice every year.
- The Safety Committee oversees the onboarding training which includes safety policies and procedures for all new staff and volunteers.

Mandatory Employee Reference: Any employee interested in moving to another Boys & Girls Club is required to have a reference from the previous Club, even if the Clubs are within the same community.

State and Local Laws: We comply with federal, state and local safety laws, including those impacting facilities and vehicles.

Safety Partnerships: Nationally, Boys & Girls Clubs of America works with leading experts in the areas of safety, security and technology to develop state-of-the-art solutions for Clubs. Partners include:

- National Child Safety Advisory Task Force, made up of leading experts and organizations
- Blue Ribbon Taskforce, comprised of local Club leaders charged with providing input on the safety direction and key safety initiatives
- Mental Health First Aid, a national program that teaches skills to recognize and respond to signs of mental illness and substance abuse
- Crisis Text Line, a confidential text message service for youth in times of crisis

- Office of the Cook County State Attorney
- Cook County Sheriffs Department
- Cook County Justice Advisory Council
- City of Chicago DFSS

Nationally, Boys & Girls Clubs of America has advocated the passage of the [U.S. PROTECT Act](#), which improved background screening systems and access. The national organization has also partnered with the [FBI](#), the [National Center for Missing & Exploited Children](#) and the [Centers for Disease Control](#) to contribute to the development of safety practices that benefit ALL youth-serving organizations.
